

Reliable and functional vehicular transportation is vital to conservation fieldwork and applied environmental management, including that with the Department of Environment and Coastal Resources supplies both as part of its recurrent work toward its remit, and its efforts towards the management of projects. DECR's field vehicle for North and Middle Caicos, the two largest and most biodiverse islands in TCI, stopped functioning in January 2023 but had already been condemned due to its deteriorating condition. DECR is requesting funding to supply a suitable field vehicle for its conservation projects on North and Middle Caicos (NCMC), including two Darwin Plus projects based on these islands (DPLUS114 and DPLUS129). It has become increasingly difficult to source vehicles through the Government procurement system and DECR has been waiting several years for the replacement of its field vehicle. The vehicle was 19 years old vehicle and in use by DECR for 13 years having been sourced in an OTEP grant in 2008; but was proposed for decommission by the Road Safety Department due to its age and condition in December 2022. In January 2023 the vehicle became permanently inoperable. DECR desperately requires a field vehicle to continue project and conservation work on these islands, including work towards the Darwin Plus projects 114 and 129, which require frequent fieldwork over wide areas. Further, whilst large-scale development has been largely restricted to Providenciales over the last 30 years, the last five years have seen new interest in developments on North and Middle Caicos. Some of these developments have included incursions into Protected Areas, which are under DECR's remit. DECR is seeing increasing occurrences of indiscriminate land clearance for development, causing significant impact to the biodiversity of North and Middle Caicos. A vehicle is required to carry out enforcement on these areas. Further, in support of other partners including the Turks and Caicos National Trust and Department of Fisheries and Marine Resource Management, both of which also locally and jointly manage Darwin Pus projects (153, 164, 181), DECR has always made its vehicle available for work towards those collaborative projects.

The former vehicle, a light pickup truck, was nearly ideal; but as the team has increased on NCMC, there is a need for more room in the vehicle cab for safety. There has also been a need for a more reliable vehicle to carry out work vital to the projects.

The grant request is simple but will permit DECR to continue its vital work and project management. The success of this application will be demonstrated by the on-schedule delivery of other project outputs and the data records from recurrent and seasonal monitoring efforts.





DECR was dependent on a 19-year-old vehicle for 13 years; as of January 2023 the vehicle is permanently inoperable.
