1. Outline progress over the last 6 months (April – Sept) against the agreed project implementation timetable (if your project has started less than 6 months ago, please report on the period since start up to end September).

Output 1 – Strengthening the evidence base for decision-making

The **scoping study** reports for each territory were finalised with further inputs from OT stakeholders and are being disseminated.

Unmanned Aerial System (UAS) **drones** and related software were procured for each OT in July 2022, based on feedback from stakeholders and advice from the consultant.

Drone training workshops were held in Anguilla from September 5-9, Montserrat from September 19-23, and Tortola, Virgin Islands, from September 26-30, 2022. In total, 21 persons (7 in each territory) representing partner agencies, civil society organisations (CSOs) and local communities were trained in how to conduct drone monitoring using standardised sargassum monitoring protocols.

During the workshops, teams in each territory conducted drone mapping surveys on at least two sargassum-affected beaches earmarked for monitoring. The teams created orthomosaic maps and elevation models as Digital Surface and Terrain Models, which will inform refinement and finalisation of the **participatory sargassum research and monitoring framework** and support ongoing systematic data collection to address key information gaps and inform decision-making. Output 2 - Mobilising knowledge for action

Knowledge, attitudes and practices (KAP) surveys were completed in target communities in each territory to capture baseline data on stakeholders' knowledge and preferences related to sargassum influxes, the impacts and management and adaptation actions. These target communities were identified based on the scoping study in terms of communities that are exposed to sargassum influxes and dependent on fisheries, tourism and other related livelihoods that are significantly impacted by influxes. The draft project communications and engagement strategy was updated based on the survey findings. See Appendix 2 for the KAP survey report and Appendix 3 for the final draft communications and engagement strategy. To validate the findings and ensure the proposed communications and engagement actions are well matched to each territory as roll-out begins, virtual workshops will be held later this year with a broad range of stakeholders from each OT and the strategy refined and finalised.

Output 3 – Improving sargassum management

The Centre for Resource Management and Environmental Studies (CERMES) has initiated work on the **sargassum management plans** for each OT, however, completion was delayed due to dependence on inputs from the completed scoping report, KAP surveys and participatory research and monitoring framework. These plans are now scheduled to be completed by March 2023.

OT stakeholders participated in the 3rd virtual meeting of the Regional Sargassum **Action Learning Network** with other government, civil society, private sector, academic and technical/intergovernmental agency stakeholders working in the Eastern Caribbean region to support knowledge exchange, learning and partnerships to improve management and adaptation to sargassum influxes. Output 4 – Project management

The **Project Steering Committee** met for the second time on October 11, 2022 and undertook the following:

Restrictions and uncertainties related to COVID-19 affected the range of data that was collected during scoping and this led to delays in drafting/updating of sargassum management plans under activity 3.1. It was therefore decided that additional data collected by local sargassum monitoring teams during implementation of the standardised drone monitoring protocols would be used to inform implementation of this activity. As such, this will delay completion of Activities 3.1 and 3.2 until January 2023 and Activity 3.3 until March 2023. Activity 3.4 (design and facilitate a 2-3-day training of trainers workshop in each OT on best practices for sargassum collection, removal and use and rehabilitation of affected areas) will therefore not be completed until Year 3, Quarter 1. CANARI is proposing that the budget for this Activity be shifted to Year 3 and will submit a formal Change Request for approval. 3.
