Progress according to specific outputs of the implementation timetable for this period are described below. Overall, work is progressing according to schedule.

- 1.4 An updated four species eradication feasibility assessment.

 Drafted by Pete McClelland and under review, due for completion Dec 23 according to implementation timetable.
- 2.2 Winter on-site equipment/materials logistics challenges mitigated.
 Electric UTV purchased to aid movement of equipment and materials on NWI. The UTV has now been shipped to NWI and is being used.
- 2.3 White-chinned petrel colony population survey, monitoring of predator pressure and targeted feral cat control activities.
- WCP colony has been surveyed and a cat control specialist contracted. We are looking at improving the habitat to give best chances of nesting and breeding success.
- 2.4 New Island biosecurity plan prepared, published and implemented by FC and all visitors. Plan drafted and implemented according to implementation timetable.
- 2.5 Obtain rat, mouse and rabbit tissue samples from NI and undertake genetic analysis. This work is proceeding according to schedule with samples being processed.

3.4 Trial results of Island Refuge and Aversion Training trials with striated caracara. These mitigation trials are due to go ahead October/November 2023. The field team has been identified, contracts made, and logistics underway.	
4.1 Communications Strategy produced and executed. The comms strategy is in draft and being updated. We are reviewing how successful different comms approaches have been, and seek to identify a consistent message to proceed to the eradication stage II.	
4.2 Meetings arranged to discuss proposals and licence applications submitted to FIG. This work has been ongoing with license applications for stage II taking place in December 2023.	
4.3 A built communications and promotional material base for Stage II This work is in progress according to schedule.	
2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.	
The threat of HPAI (Bird Flu) remains. Currently the Falklands is free from the virus, but it is present at similar latitudes on the South American continent, and as such likely to arrive in the Falklands this season with migrant birds. If the disease arrives, FIG will automatically revoke all research permits and suspend all fieldwork. This risks much of the work that is due to take place in the field, such as mitigation trials with Johnny Rooks, surveys of White-chinned petrel, etc. If it is appropriate to resume fieldwork, we will have to go through an appeal process to FIG to secure a new research permit. Although the risk is beyond our control, at this point we remain hopeful that the disease doesn't arrive, and confident that should it arrive the overarching aims of the proposed work can be met within the project timeframe. We are prepared to develop appropriate contingencies, depending on how the situation evolves.
